  - The proclamation highlighted his leadership on significant projects like the new facility, consolidation efforts, the fire funding formula, and hiring the new director.
  - Mayor Brummel expressed his pride in DU-COMM, its staff, and the teamwork involved, stating he would miss the people he worked with.

Administrator Guttman made a motion to approve the Consent Agenda items A, B, C, D as presented, and Manager Fieldman seconded. Motion passed by a unanimous roll call vote.

## 6. Executive Director Update

Director Robb reported:

- Text-to-911 went live county-wide on April 8th in conjunction with ACDC.
- An example was shared of a 7-year-old successfully using the service to report a domestic disturbance.
- RapidSOS is being implemented in early May to integrate various school safety alarm systems (panic alarms, active shooter alarms) from different vendors.
- Efforts are underway to enhance collaboration with ETSB regarding vendor contracts and system configuration to improve operational agility.
- DU-COMM is actively researching and evaluating emerging 9-1-1 technologies like AI for quality assurance and pursuing advancements like the Real Time Crime Center (RTCC).

### 7. Old Business

A. Strategic Plan

 The Director presented the final Strategic Plan, noting it was a year-long collaborative process involving all levels of DU-COMM staff and member agencies.

Manager Niehaus made a motion to approve the Strategic Plan as presented, and Administrator Guttman seconded. Motion passed by a unanimous roll call vote.

#### 8. New Business

- A. Select Nominating Committee for 2025 Board Elections
- The bylaws regarding the nominating committee process and board structure were read.
- Three members volunteered for the nominating committee: Mayor David Pileski (Roselle), Manager David Fieldman (Downers Grove), and Manager William Holmer (Carol Stream).
- No further nominations were made from the floor.
- The deadline for volunteering for board/executive committee positions is the last Friday in May.

Chief Krestan made a motion to approve Manager William Holmer, Manager David Fieldman, and Mayor David Pileski as the 2025 Board Elections Nominating Committee as presented, and Administrator Walter seconded. Motion passed by a unanimous roll call vote.

- B. Fire Protection District 2025 Nomination Slate
- The Fire Protection Districts met on April 9th.
- The recommended slate for the four FPD seats on the Board of Directors is: President James McCarthy (Bartlett FPD), President Longry Wang (Lisle-Woodridge FPD), President Kate Perkins (Warrenville FPD), and Trustee Jim Williams (York Center FPD).

Administrator Guttman made a motion to approve the Fire Protection District 2025 Nomination Slate as presented, and Manager Niehaus seconded. Motion passed by a unanimous roll call vote.

### C. STARCOM

Administrator Guttman made a motion to direct DU-COMM applying as a STARCOM user as presented, and Manager Niehaus seconded. Motion passed by a unanimous roll call vote.

- Mayor Brummel retires on May 5, 2025, creating a vacancy until the July 2025 elections.
- Bylaws state the Chairman of Board of Directors shall appoint a successor to fill the vacant office until the next biennial election for that office.
- Mayor Craig was appointed as Interim Chairman until the next election in July 2025.
- B. 50th Anniversary Open House
- Reminder that the open house is September 7th, 1:00 PM 5:00 PM; all are invited.
- C. Text-to-911:
- In response to a question, Director Robb noted dispatchers are versatile and adapt well to the new technology; the integration has been successful so far.

# D. ETSB Updates

Manager Mark Franz noted

- Fire radio deployment hoping for a rollout in the next 2-3 months.
- CAD/RMS RFP process has begun; seeking volunteers for the task force.
- The ETSB Budget Committee is seeking volunteers.

## E. 9-1-1 Surcharge Increase Effort

Attorney John Kelly reported

- An effort is underway by 9-1-1 directors statewide to increase the surcharge from \$1.50 to \$2.50 and index it
  to the cost of living. No specific bill is named yet; potential inclusion in the state budget bill is being
  discussed.
- Discussion about loosening restrictions on fund usage is considered risky, as it might lead to tighter restrictions instead. Current rules align with FCC guidelines. Personnel and radios are currently eligible costs.

### 11. Adjournment

At 8:20 a.m. Administrator Evan Walter made a motion to adjourn, and Manager Fieldman seconded. The motion was approved by voice vote. Meeting adjourned.
