#### A. Staff

Director Robb reported:

- Phone Cutover
  - The phone cutover is still on track for Tuesday, October 22<sup>nd</sup>.
  - There may be a delay in going live with texting to 9-1-1
  - Public education materials regarding Text to 9-1-1 are still pending.
  - The Next Generation 9-1-1 information session will be held on October 18th for Chiefs.
  - Phone system operational readiness testing has been conducted all week.
- Hiring Update
  - Assessment Center was conducted for open management positions.
  - Offers will be made by Monday with one internal candidate.
- Agency Sit-a-longs
  - TCs are excited sit-a-longs have been scheduled again.

#### B. ETSB

Director Robb reported:

- Concerns about Prepared product.
  - The software appears to overlap the functionality of the RapidSOS system.
  - RapidSOS
    - Provides satellite maps, which are more accurate than cell towers. Can provide the estimated floor of the apartment building the caller is located.
    - Medical information stored in the caller's iPhone is shared.
    - Call takers hear a ding before the phone rings in the Center.
    - TC can see how many times the number has called 9-1-1.
    - For a text message it will provide the location of the cell number (similar to a phase II location with a cell call).
    - Ability to integrate with 3-D mapping and camera systems.
- Several members of the ETS Board are retiring or leaving.
- Concerns about the departure of the Deputy Director of Operations for the ETSB.
  - The DDO is not being replaced at this time

#### 6. Old Business

A. FD Channels - Update

Chief Tanner reported:

- Templates:
  - A final template will be required from all agencies.
  - Instructions will be provided on how to submit the final template.
  - The deadline for submission will be before the Thanksgiving holiday.
- Portable Radios:
  - o Portable radios are close to being ready for distribution.
  - o Encryption for the police side is pending ETSB approval in November.
  - Speaker microphones with channel selectors may cause delays in receiving portable radios.
- Mobile Radios:
  - No clear timeline for mobile radio replacements.
  - o The viability of the 8500 model is still under review.
  - o The 6500 model may not be a suitable dual band, dual head solution.
  - A single head 6500 model is now being considered as an option.
  - o Long-term solutions for mobile radios are still uncertain.
- Additional Discussion:
  - Concerns about the lack of clear direction and timelines for the mobile radio project.
  - Importance of continued input and attendance from fire agencies in the decision-making process.
  - Need for a dual head, dual band radio solution.
  - Frustration with the lack of progress on the mobile radio project.

A. Fire Operations Subcommittee Chairman

Chief Tanner noted:

- Chief Fors is recommended to take over as chairman.
