### 3. Staff Reports:

Training Manager Schretter reported

- Staffing
  - Two TCs will be certified for Police within the next three weeks.
  - o Three new trainees begin on Wednesday, October 2.
- Sextortion resources are available for agencies.
- Vesta phone cutover is scheduled for Tuesday, October 22 with training starting next week.

### Director Robb reported

- Interviews scheduled for the first week of October for the OM and QA positions (nationwide interest).
- Executive Committee discussed auto dialers in schools
  - Auto dialer system is an automated message "there is an emergency" and want it to go to 9-1-1 instead of a 7-digit number.
  - The call will go to a 7-digit line. An Officer will go to investigate, and Dispatch will call the school for more information.
  - o If the alarm company contacts DU-COMM directly what should the procedure be?
  - Current legislation does not allow auto dialers to call 9-1-1.
  - Need to have standardization. Each district having different systems will cause issues in the Dispatch Center.
  - DU-COMM is not a monitoring service. The alarm can be integrated to RapidSOS but a TC still has to acknowledge the alarm because it is not part of CAD.
  - Concern, the 7-digit line is not looked at first if very busy.
  - The School Safety meeting discussed indoor mapping with the ROE school specialist and hope to have requirements for the school safety systems.
  - Lisle has CrisisGo and asked if it could message the cell phone on the bridge? DU-COMM can't monitor it consistently.
  - Schools are receiving grants for school security.

- BluePoint partners with the school. Their alarm is for an active assailant not for a fight or asthma attack. BluePoint is monitored by a staff member, not an automatic message.
- Dedicated position of an alarm board is an idea.

#### 5. New Business:

A. Burglar Alarm (Intrusion Alarm) Processing – DD Benjamin Director Robb reported

- Proposal from ACDC (Addison Consolidated Dispatch Center) for PD alarms adding sub
  type levels 0-4: Level 0-No call for service, priority 4; Level 1-General-no additional
  information, priority 2; Level 2-Human present, priority 2; Level 3-Prop threat-human
  presence with threat to property, priority 1; and Level 4- Life threat, priority 1.
- The Subcommittee noted comments are put in CAD and Dispatch can advise. Do not need specific CAD codes. Why make a code when you state what it is?
- Five years into this CAD system-suggest hold until the next update. Going to RFP for CAD.
- Agencies use commercial vs. residential for alarm billing and need to know that for their response.

### B. PD Channel Template Review

Technical Services Manager Maplethorpe noted

- Templates are being finalized with minor changes for Police.
- Motorola is working on the encryption plan.
- Zone 1 A choose 1-9. 1 primary 2 tac channel
- Zone 2 B 800 PD Backup (if Starcom goes down unexpectedly)
- Zone 3 C TAC channels. ACDC removed their name from their TAC channels. DU-COMM is unchanged.
- Zones beyond the first three are already determined and are the same for everyone
- A new user select zone allows for 16 channels of whatever channels you want.
- Talk group changes.
  - o For sensitive investigation PD region 1-4 don't want anyone to hear (i.e. investigate your own) can request to lock the channel down for a limited time.
- Five encryption keys: main dispatch shared with TAC channels, States Attorney or special use, interops (not border agency to DuPage), statewide share the key, and special investigative.
- Fire agencies will not have access to statewide TAC, investigative, merit, or countywide PD channels.
- DPSO "court" talk group now called "JOF" (Judicial Office Facilities)
- Templates will go to PAC in two weeks then ETS Board for final approval.

#### 6. Other Business

# A. Dispatch Sit-a-longs

- At DU-COMM's All-Agency meeting TCs requested sit-a-longs return.
- Since COVID we have not had Officers in Dispatch.
- Recommend new hires and newly promoted Officers schedule a time for TCs to explain what they do.
